1. Adults who have been convicted of either child sexual or physical abuse should not volunteer service in any church sponsored activity or program for children or youth.
2. Volunteers should observe the “two person” rule. This requires that volunteers are never alone with children without a partner.
3. Volunteers should immediately report any behaviors which seem abusive or inappropriate to the Children's Director.
4. All volunteers eighteen and older are required to have a background check approved before being allowed to serve with children.

## WHAT WE BELIEVE at CHEYENNE HILLS CHURCH

It is important that we are unified in the following beliefs that are held by the larger body of Cheyenne Hills Church. If you have questions or concerns about any of these, please reach out to the Children's Director who would love to discuss and work through this with you.

### THE WORD OF GOD

We believe that the Bible is the Word of God, fully inspired and without error in the original manuscripts, written under the inspiration of the Holy Spirit, and that it has supreme authority in all matters of faith and conduct.

### THE TRINITY

We believe that there is one living God, eternally existing in three persons, that these are equal in divine perfection, and that they execute distinct but harmonious offices in the work of creation, providence, and redemption.

#### *God the Father*

We believe in God the Father, an infinite, personal spirit, perfect in holiness, wisdom, power and love.

We believe that He concerns Himself mercifully in the affairs of men, that He hears and answers prayer, and that He saves from sin and death all who come to Him through Jesus Christ.

#### *Jesus Christ*

We believe in Jesus Christ, God's only begotten Son, conceived by the Holy Spirit.

# CHILDREN'S MINISTRY FOUNDATIONS

## Vision:

Our deep desire is that every child would be disciplined to know God personally, finding their identity, freedom, and purpose in Christ alone, and inspire others to do the same. (Ephesians 1: 5-10)

## Mission:

To provide an intentional opportunity for children to explore, engage and be empowered in their faith formation.

### The 3 E's:

Explore the love of Christ through scripture so that children can know God and who they are in His eyes.

Engage them in learning the gospel, in hopes of a Spirit-led faith commitment to Jesus Christ and a resilient relationship with Him.

Empower them to discover their God-given gifts and be active movers for the kingdom of God.

## Philosophy:

Our philosophy is to be a point of connection between the family and the church by offering an inviting place where children are excited to come learn about Jesus (Mark 10:13-16). We aim to come alongside families to provide relationship and resources as they take on the role of primary spiritual developers in their children's lives (Deuteronomy 6:4-9). Through this partnership, we strive to build an unshakable Biblical foundation (Proverbs 22:6); amplifying the immutable truth of God's Word over the noise of this world.

## Values:



- **Make it safe:** We are dedicated to providing an environment that is as safe and loving. From the application process of volunteers to the security procedures in place, our team works diligently to ensure the safety of the children placed in our care.



- **Make it Biblical:** We are fearlessly committed to the truth of the Bible and sharing it in an age-appropriate way.



- **Make it personal:** We value building relationships with all the individuals that God places in our midst. From volunteers to parents to children, we aim to connect in authentic ways in order to find fellowship and lift one other up in our walks with God.



- **Make it together:** We value the hearts, experiences, and skills of every member of our team and the families they work with. We strive to continue building and strengthening the ministry through collaboration.

## Children's Ministry's Highlighted Policies for Volunteers:

### Discipline

Discipline within children's ministry programs at CHC consists of positive reinforcement and redirection. The use of physical punishment or harsh verbal/emotional interaction of any kind is not permitted. If neither of the positive techniques works to resolve the problem, the parent/guardian will be called to remove the child from the program. Children who are actively harming themselves, other children, or adults will not be allowed to continue and may be removed at staff discretion. Significant behavioral concerns should be reported to the Children's Director, who will discuss the problem with the child's parents.

### Child Abuse and Neglect

The state of Wyoming requires us to watch for suspected cases of abuse and or neglect. As a volunteer at CHC, you are legally obligated to report any suspected cases of abuse or neglect. If you suspect abuse or neglect of any kind, please inform the Children's Director and she will contact DFS for further investigation.

### Security

The security of children in our ministry is critically important. All children and volunteers must check in and receive a tag before attending CM programs. Parents will receive a guardian tag that needs to be returned by an individual, 18yrs of age or older, at the end of the program to pick up the child. Volunteers must receive said tag before releasing a child to that person, even if you know them. There are family situations we may not be aware of and releasing a child to someone, even a parent, who does not possess the coordinating tag, compromises the safety of that child. Only volunteers/staff members, who have gone through the application/screening process, may enter a classroom. It is important that all safety procedures be strictly followed.

Present you with a vision for the children's ministries and compelling reasons why you should subscribe to that vision.

Help you discover your place in ministry. Whether this is in CM or not, we will help you discover your unique spiritual giftedness and passion.

Support, encourage, and do everything we can to help you be successful in ministry.

Provide adequate resources, materials, supplies, training, etc. so you can focus on your ministry.

Communicate with you. We will provide regular updates so that you will be informed about all things in CM including schedules, new ministries and volunteers, activities, curriculum, etc.

Clearly communicate with you regarding your position in ministry, including what we expect you to do and feedback about how you are doing.

In the context of ministry teams, we will build community with each other. We will strive to develop a family atmosphere among teams. We will take an active interest in your life. We will encourage you and pray for you. We will hold you accountable in your walk with God. We will lift you up and help you physically if need be. We will value you, putting your needs as a person and as a child of God ahead of your responsibilities to the children's ministry.

***We will expect you to:***

- **ADHERE** to all CHC CM policies.
- **ATTEND** trainings and meetings.
- **REPORT** abuse or suspected abuse to staff.
- **LIVE AS DISCIPLES** of Jesus. Model life with Christ for the kids to see. Your life can be a powerfully impacting witness.
- **SUBSCRIBE** to the mission, vision, and values of CHC's CM.
- **LET YOUR YES BE YES.** Follow through on your commitments to the kids and to the ministry team. If you are signed up to help and cannot make it, please do your best to get yourself covered AND let us know ASAP so we can help find a replacement for you. Last minute cancellations are very hard for us to fill and all the kids still show up. It is not fair or fun to the other scheduled volunteers to be understaffed in the classroom. We understand that last minute situations come up, but if you know in advance that you will not be able to fulfill you scheduled Sunday let us know. Please be aware that we will swap you with another volunteer's scheduled Sunday. In most cases it will require you to serve two Sundays in a row to make up for your missed scheduled Sunday.
- **FULFILL** the specific requirements of your ministry position.
- **ARRIVE ON TIME**, ½ hour prior to the start of your scheduled service.
- **COMMUNICATE** with us. Tell us your needs, ideas, concerns, questions, dreams, and hopes.
- **LOVE** the kids and families! Build relationships with them. Share your faith and pray for them. Encourage and listen to them.
